Follow-up to Chicago Creek Society letter of October 8, 2020

Gail;

I am writing to remind the District of our Society's request for your support for the Minister of Transport to order an independent Risk Assessment of the proposed increase in shipments of petroleum products through the CN northern corridor for export via Prince Rupert or Kitimat. I previously forwarded a number of our concerns/questions at your request on November 11, 2020.

We understand the long-standing cooperative relationship between DNH and CN relating to stream management in District boundaries. We do not wish to disrupt this relationship, but feel the issues arising from the proposed exports require careful assessment and preparation by all communities, First Nations, and regional districts through the corridor. As you are aware, a number of communities and boards in the region have already determined that an independent risk assessment is the best foundation for this.

I understand, from our previous conversations, that the District was waiting for RDKS to take the lead on this matter. Given the results of the survey of emergency preparedness filed with the RD by Rick Boehm, we will also be renewing our request to the Regional District for a decision on our request.

I would request an opportunity to meet in person with you (and Wendy, if you wish) to get a better sense of the District's concerns in this matter and how we might move forward with it.

Dear Mayor and Council:

Request for letter to Transport Minister:

In conjunction with other environmental groups in the Regional District, we are writing to express our concern for public safety and the safety of our watershed given the proposed dramatic increase in shipments of hazardous petroleum products on the Northwest rail corridor. Specifically, we are asking you to write the Minister of Transport requesting a risk assessment under the *Railway Safety Act*.

As you are already aware from previous submissions relating to this topic, Vopak, teamed with AltaGas to build a propane terminal at Prince Rupert . AltaGas is the first propane export terminal on Canada's west coast and it requires 50 to 60 propane tank cars per day. In addition, a second proposed propane export facility is undertaking geotechnical work in Kitimat. Pacific Traverse Energy has received a 25-year propane export licence from the National Energy Board and, if built, will require 60 propane rail cars a day.

As a result of these developments, unit trains of pressurized propane tank cars and other products are now regularly passing through the Regional District along the northwest CN rail line. If all export plans come to fruition, a total of 300 such rail cars per day could be travelling through our region and communities in the future, in each direction.

While the terminals proposed for Prince Rupert and Kitimat will be subject to environmental review, at present there appear to be no plans by senior levels of government to conduct a risk assessment (relating to either environmental impact or public safety) or to review of spill response plans relating to the transport of these products through the northern rail corridor. As the District is responsible for emergency response within its jurisdiction under the BC Emergency Management System (ref. BCEMS Guide, 2016), we feel this issue should be of direct concern to the District of New Hazelton.

As you know, our Society's direct interest in rail safety arose as the result of a 2018 spill by a CN coal train in to Mission Creek at the New Hazelton border. Mission Creek has been the focus of the Society's efforts to restore salmon stocks and improve habitat since our incorporation in 1995. At the time, we observed in our internal discussions that we were fortunate that the spill

was a relatively inert (though still potentially toxic) material and not liquid petroleum products. Then the Vopak/AltaGas and Traverse Energy proposals came along

Should a similar derailment which resulted in the coal spill into Mission Creek occur with a petroleum product unit train, it is our understanding that responsibility for planning and implementation of emergency response and evacuation procedures would fall to the District.

For your information, we have again attached 3 maps showing evacuation areas in the Hazeltons which would be affected should a propane, diesel, or methanol spill or fire occur in our area. The potential impact on New Hazelton can clearly be seen in those maps.

For the above reasons, we request that, as elected officials:

The District of New Hazelton write the Honourable Marc Garneau requesting the Ministry of Transport initiate an inquiry under the *Railway Safety Act* of the proposed increase in flammable hazardous shipments on the Northwest BC rail corridor.

This assessment should be conducted before any further increase in hazardous goods traffic. The assessment would need to identify risks and remedial actions for possible adverse environmental effects including spills into watersheds, public safety issues and climate impacts.

Per our brief telephone conversation this morning, attached please find a list of questions/concerns that were developed as follow-up on this issue. While these are framed as questions we would like to see CN address, they are also questions that we believe the District of New Hazelton needs to be able to answer to ensure the safety of its residents.

As mentioned, some were addressed in CN's presentation to RDKS, but some were only partially addressed or did not receive definitive responses. For example, CN's safety officers emphasized that 117 cars were in use for the majority of shipments of diesel, but did not say that no retrofitted 111s were in use. Similarly, they advised of location of CN's fire suppression cars (PG, Edmonton, Winnipeg), but did not specify how long it would take them to reach our area.

I appreciate the time and attention that the District has given to this issue, both in the past and the present. I would also appreciate if you could advise us of the District's response to our request of October 8th, when you are in a position to do so.

Questions for CN to Address Relating to Response to a Unit Train Derailment in Northern BC

- 1. Rail Tank Cars in Use to Transport Flammable Liquids
 - Are TC-117 cars in use for transport of diesel products, or are DOT-111s (retrofitted) still in use?
 - Which types of cars are currently in use for transport of LPG and Methanol?
- 2. Notification to Citizens in Event of Need to Evacuate
 - What is your understanding of the current mechanism for advising citizens in an evacuation zone of the need to evacuate and where to go, in the event of a unit train incident or derailment?
 - Has CN consulted with all regional districts, first nations, municipalities or other levels of government responsible for emergency response along the CN northern rail corridor to ensure they have the capacity for informing citizens?

3. CN Response time

- Where are CN's resources to deal with a unit train derailment located?
- What is your estimated response time to the District of New Hazelton?
- 4. First Responders PPE (Personal Protective Equipment)
 - What personal protective equipment would be required by first responders (police, fire, ambulance or other personnel) dealing with an incident or derailment involving a unit train?
 - Is necessary PPE available for first responders in each community, regional district, or first nations territory along the route(s)?
- 5. BLEVE (Boiling Liquid Expanding Vapour Explosion)
 - What is the volume of water required to prevent a BLEVE in event of a puncture or leak in a tank car carrying liquid propane?
 - What is the likely outcome, in the event the capacity to pump the necessary volume of water does not exist in the vicinity of a leaking, punctured or derailed propane car?
 - What is the estimated force of a BLEVE in a single propane tank car?

6. Firefighting Capacity

- Which communities along the CN northern rail corridor have been identified as having sufficient capacity (personnel, PPE, and equipment) to deal with a unit train derailment resulting in fire?
- In which areas of the corridor is there insufficient capacity in the event of a unit train derailment resulting in a fire?
